There is nothing like the fun of summer and freedom of riding a bike, especially for youth at Vera Lloyd. First Presbyterian Church of Bentonville and Board member Renee Nestor helped make both happen.

Through a church grant, Renee arranged for the purchase, assembly and delivery of bikes. On Bike Delivery Day, youth waited eagerly in line for their turn to receive their bike. One by one, the campus filled with kids zooming around. Staff reported that it was literally a traffic jam, and driving a car on campus became impossible



that afternoon. In 97 degree weather and 100% humidity, the staff were sweating, but the kids were having the time of their lives.

Two brothers, Alex (14) and Joel (17) were particularly elated. They became residents of Vera Lloyd's Pettus Home this summer. Neither of them know their father, and after their mother abandoned them, they were left to fend for themselves. Joel did everything he could to take care of his little brother and himself but made the brave decision to seek help. Shortly after reaching out to a friend, they came to Vera Lloyd.

At first, their walls of self-protection were high. Experience taught them that expressing emotion was a sign of vulnerability, but Bike Delivery Day was a milestone, particularly for Alex. He tried so hard to contain his smile, but it was impossible. Grinning from ear to ear, he and Joel rode around campus and began to release their fear.

Today, just months since their arrival on campus, they are thriving academically and socially. Alex and Joel ride their bikes every day, rain or shine, smiling and becoming more light-hearted with each passing day. The bikes were an incredible blessing to all of Vera Lloyd's kids, because the truth is, they aren't just riding bikes; they're moving towards hope, freedom and joy.

Financial planning seems to get more complicated every day. Laws change, and it can be overwhelming to figure out all the rules. Did you know that you can meet the IRS tax code AND help the youth at Vera Lloyd?

IRS rules mandate that individuals age 70 ½ and older take Required Minimum Distributions (RMD) from their IRA each year, regardless of whether the income is needed. These annual withdrawals are subject to ordinary income taxes. By making a charitable contribution from your IRA, you can satisfy your RMD amount without reporting additional income.

If you don't need all your income to meet current living expenses, charitable donations may be a great option. You can enjoy the satisfaction of knowing that you are changing the life of a vulnerable child and lowering your tax bill in the process.

What You Need to Know

- Gifts can be made through a Traditional IRA or Roth IRA.
- You may give up to \$100,000 in charitable gifts from your IRA each year.
- Qualified Charitable Deductions must be made during the calendar year of the tax return, directly from the IRA custodian to Vera Lloyd or other charities.
- Speak to your tax advisor in advance to find what works best for you.

- Support vulnerable children, youth and families!


